Plan to pull rods, pump & tbq., run junk basket on wire line to 4316', set bridge plug in 5-1/2" csg. @ 4270' & spot 1 bbl. Class C neat cement (3-1/2 sks.) on top of bridge plug and WOC and check top of cement. With tbq. at 2980', spot 150' cement plug in 5-1/2" csg. With tbq. at 1690', spot 150' cement plug in 5-1/2" csg. WOC and check top of cement. Spot 100' cement plug in 5-1/2" csg. to surface. Remove wellhead, install marker and restore surface to natural contour to P&A.
