3. Spot 100' cement plug 4050-3920'.
4. Spot 100' cement plug 265-2565'.
5. Spot 100' cement plug 105-963' (Across 7" csg stub)*
6. Spot 100' cement plug 95-770' (Across 10-3/4" csg shoe)
7. Spot 10 sx. cement plug surface.
8. Install Dry Hole Marker. Plug and Abandon.

*If 7" csg stub cannot be re-entered, leave open and install gauges to monitor pressure.
