Field Vacuum Grayburg / San Andres
County Lea State New Mexico

RECOMMENDED PROCEDURE

- 1) Set 7" cmt retainer on 2 3/8" work string @ 4100'±
- 2) Squeeze open hole (4200'-4890') w/ 275 sx class "C" neat cmt
- 3) Spot a 35' plug on retainer w/ 6 sx cmt, minimum.
- 4) Load hole w/ mud laden fluid using 25 lbs gel / 1000 gal
(min density should be 9.5 lbs/gal)
- 5) Spot a 100' plug across the salt base (2,650'-2,750')
w/ 17 sx cmt
- 6) Perforate 7" CSG @ 1,000'-1,002'; 45SPF Bleed off
all resulting pressure and water flow. Set 7" cmt retainer
@ 950' and attempt to circ cmt to the surface w/ 250 sx
- 7) Spot a 35' plug on retainer w/ 6 sx cmt
- 8) Spot a 20' plug @ surface w/ 4 sx cmt
- 9) Erect a P&A monument
- 10) Clear location

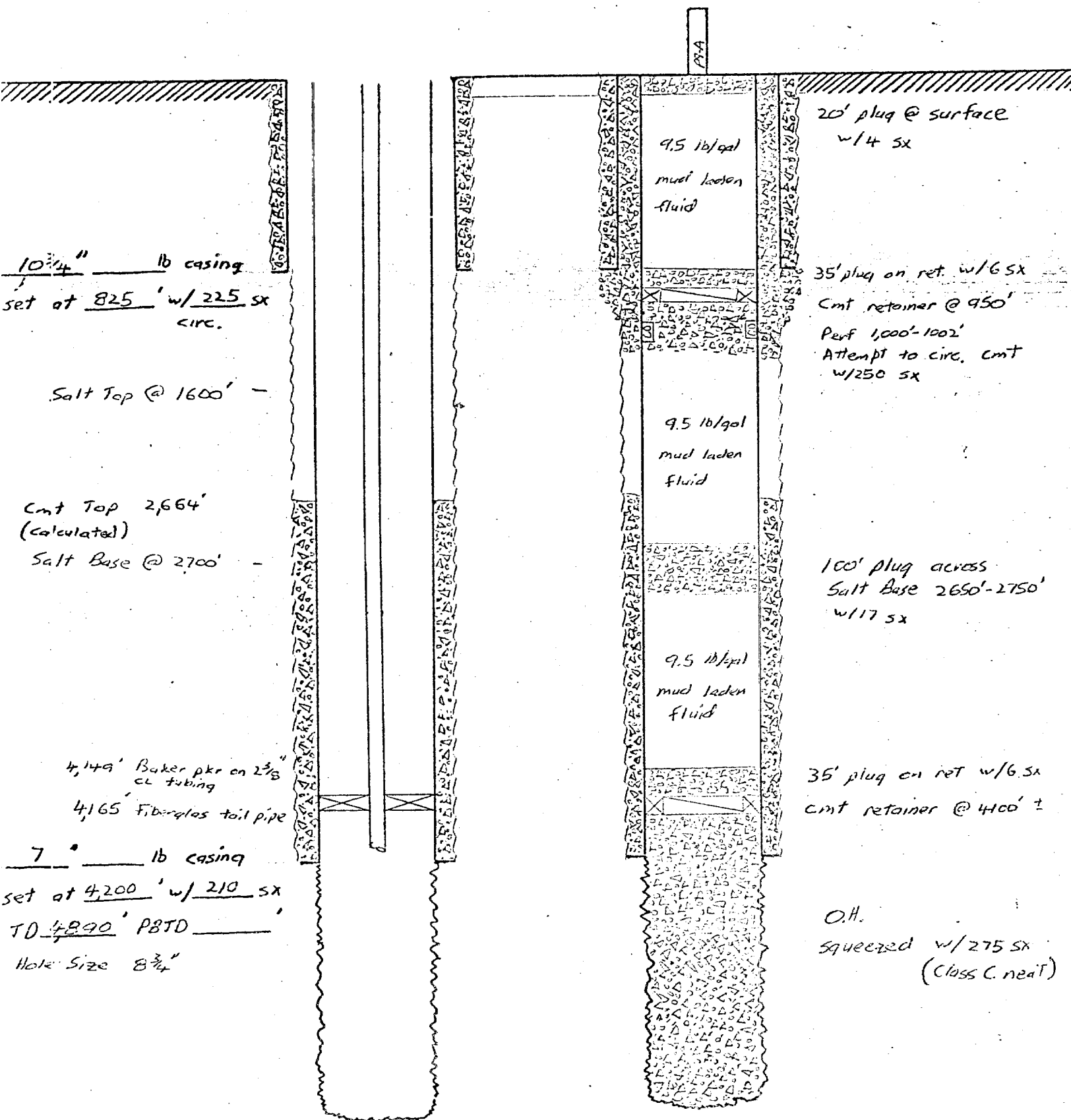
