FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production we propose to do the following work:

1. Pump well down and inject a mixture of 55 gallons of Cheplex in 500 gallons of 5% hydrochloric acid into the tubing-casing annulus.
2. After a period of 24 hours, pull rods and tubing.
3. Clean out to total depth if necessary.
4. Fracture open-hole section from 4353' to 4753' down 3-inch tubing with hookwall packer set at 4310' in 3 stages; each of 10,000 gallons of refined oil carrying one pound of sand per gallon with 1000 pounds of flaked naphthalene between stages.
5. Recover load oil, test, and return to production.
