Pull rods & tubing, clean out to TD 4728'. Run 3" frac string with RTTS packer set near bottom of casing at approximately 4600'. Acidize with 2,000 gallons acid, followed by frac treatment of 30,000 gallons refined oil and 28,800# sand. Pull frac string, run rods and 2" tubing, place well on pump. Work done October 6, 1964.
