FULL DETAILS OF PROPOSED PLAN OF WORK
 (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production we propose to do the following work:

1. Clean out to total depth if necessary.
2. Inject a mixture of 55 gallons of Cheplex in 500 gallons of 5% hydrochloric acid into the tubing-casing annulus.
3. After a period of 48 hours, pull tubing.
4. Fracture open hole section from 4213' to 4710' down 3-inch tubing with hook wall packer set at 4170' in 3 stages; each of 10,000 gallons of refined oil carrying one pound of sand per gallon with 1000 pounds of flaked naphthalene between stages.
5. Return to production.
