FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

To increase production we propose to do the following work:

1. Pump well down and inject a mixture of 55 gallons of Cheplex in 500 gallons of 5% hydrochloric acid down the tubing-casing annulus.
2. After a period of 24 hours, pull rods and tubing.
3. Fracture open-hole section from 4251' to 4712', in three stages, down 3-inch tubing with a hookwall packer set at 4206'; each stage to be 10,000 gallons of refined oil carrying one pound of sand per gallon with 1,000 pounds of flaked naphthalene between stages.
4. Swab, recover load oil, test, and return to production.
