FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

- 1. Inject a mixture of 55 gallons of cheplex in 500 gallons of 5% hydrochloric acid into the tubing-casing annulus after pumping well down.

- 2. After a period of 24 hours, pull rods and tubing.
 3. Clean out to total depth if necessary.
 4. Fracture the open-hole section from 4230 to 4685 in 3 stages; each of 10,000 gallons of refined oil carrying one pound of sand per gallon, with 1000 pounds of flaked naphthalene between stages down 3 inch tubing with hook wall packer set at 4180'.
- 5. Recover load oil, test, and return to production.
