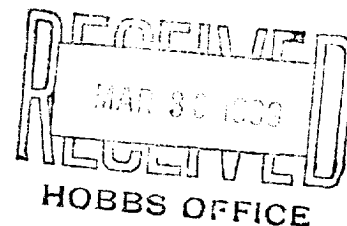

Set and cemented 1604' of 7-5/8" 26.40# LW Casing at 1617' with 660 sacks cement. Completed cementing at 5:30 P.M. 3-26-39. Ran 260' of 1" tubing behind 7-5/8" casing. Circulated with 160 sacks of El Toro Common cement. Completed cementing at 12:00 Noon, 3-28-39.

Expect to drill plug and test by pressure method after 48 hours or at approximately 12:00 Noon, 3-30-39.
