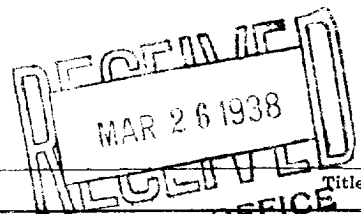
## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED
