FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to do the following work on subject well:

1. Inject a mixture of 55 Gals of cheplex in 500 Gals of 5% hydrochloric acid into the tubing casing annulus after pumping well down.
2. After a period of 24 hours, pull rods and tubing.
3. Clean out to total depth if necessary.
4. Fracure the open hole section from 4225' to 4675' in 3 stages each of 10,000 Gals refined oil carrying one lb of sand per Gal, with 1000 lbs of flaked naphthalene between stages down 3 inch tubing with hook wall packer set at 4200'.
5. Recover lost oil, test, return well to production.
