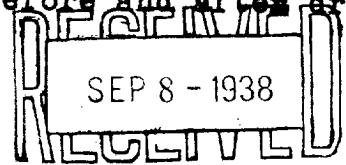

Set and cemented 1525' (65 Jts.) of 7-5/8" OD, 26.40#, lapweld casing at 1537' with 300 sacks of El Toro cement. Completed cementing at 4:15 PM. 9-2-38.

Drilled plug at 4:40 PM. 9-4-38. Tested casing before and after drilling plug with 1200# pressure. Tested OK.
