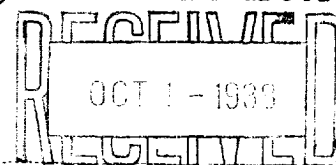

Drilled plug at 1:30 PM. 9-25-38. Tested casing before and after drilling plug with 1200# pressure. Tested OK.
