Set and cemented 1534' of 7-5/8" OD 26.40# Lapweld Casing (67 jts) at 1548'. Cemented on bottom with 200 sacks. Ran 200' of 1" pipe behind casing and circulated with 80 sacks. Completed cementing at 6:00 PM 9-13-39.

Drilled plug at 1:00 AM, 9-16-39. Tested casing 1 hour before and after drilling plug with 1200# pressure. Tested OK.
