Found top of cement outside 13-3/8" casing at 130'. Cemented thru 1" pipe with 200 sacks. Circulated into cellar. Found top of cement inside 13-3/8" casing at 76'. Drilled cement ~~WORK~~ and plug at 435'.**  
**After waiting on cement over 24 hours, tested below 13-3/8" casing with 400#, 30 min. OK.**
