FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On July 10, 1949, at 1:00 p.m., 48 hours will have elapsed since running 2004' #f 8-5/8" casing set at 1997 and cemented with 1300 sacks to be used as intermediate string. Cement will be circulated to surface. At this time it is planned to test pipe and water shut off by applying 1000 psi pressure and holding for 30 minutes, before and after drilling cement plug. If pressure drop in excess of 100 psi occurs on either test, proper remedial measures will be carried out. In the event the above tests satisfactorily meet requirements, drilling will be resumed.
