DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

T. D. 4645 **Lime.** Killed well with 150 bbls. oil, pulled tubing and reran 2" USE tubing to 4623' with Guiberson hook-wall packer set 4175'. Placed 60 bbls. oil in annular space above packer. Introduced 1500 gal. Dowell **KXW6F6** and flushed tubing with 18 bbls. oil. Swabbed off bottom 26 hrs. and recovered 210 bbls. oil load & acid. (Packer leaked, swabbed out oil which was above packer). Swabbed 16 bbls. fresh oil in 2 hrs. & well started flowing. Flowed 135 bbls. oil, no water in 12 hrs.
