



## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

With 9 5/8" Seamless casing set @ 1762' and cemented w/ 450 sacks of cement on October 23, 1938, the well was allowed to stand undisturbed for a period of 72 hours. Pump pressure of 1200# was then applied to the pipe and fittings. The valves were closed and the pressure within was observed for a period of 30 minutes. There was no drop in pressure. The cement plug was then ~~drilling~~ drilled and the same test again applied to the pipe and fittings. There was no drop in pressure. Drilling was resumed October 26, 1938.


