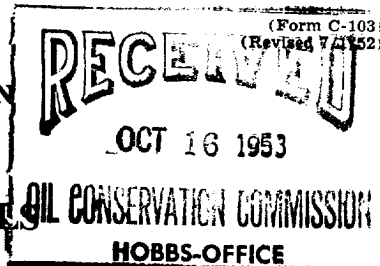

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Formation line

Treated 9570-9590' with 1000 gallons Western 15% regular acid. Maximum and minimum tubing pressure 3500 to 3000#. Inj. rate 1.0 to 1.4 barrels/min. Flushed tubing with 38.5 barrels water. Scrubbed and tested 3 hours - recovered 25 barrels fluid with slight show of gas when scrub was pulled and trace of oil.
