Pull rods and tubing, clean out to TD 4587', run 3" frac. string with RTTS packer set near bottom of casing at approx. 4120'. Acidize OH section (4120-4587) with 1000 gallons acid, followed by water frac. treatment of 30,000 gallons and 25,000# sand. Pull frac. string, run rods and 2" tubing, place well on pump.
