

**3-27-72/4-9-72: MI RU Wells WS unit. Pulled rods and tbg. Ran tbg OE to 9030'. Howco pmpd 200 BW down csg and 100 BW down tbg, both under vacuum. Cntd down tbg w/200 sx Class H cmt flushed w/20 BW. Tagged TOC at 8692'. Howco cmtd down tbg w/150 sx Class H, flushed w/20 BW. Tagged TOC at 8685'. Cntd w/200 sx Class H cmt, flushed w/30 BW. Pulled tbg to 7000', pressured w/500# for one hr. Lowered tbg to 7700', reversed 7 sx cmt. Lowered tbg to 8000', reversed 30 sx, reversed 35 sx at 8300' and 35 sx at 8600'. WOC 15 hrs, tagged at 8600'. Ran bit & csg scraper to 8621'. El Toro perforated 5-1/2" csg w/2--3/16 jet shots/ft at 8556-86', 30', 60 holes. Set 2-3/8" tbg at 8508' and 2" x 1-1/4" x 16' pmp at 8505'. Pumped and tested well, restored to production from Abo perforations 8446-8566', PSTD of well 8621'.**

**(Abo perfs 8616-8868' squeezed plugged and abandoned.)**
