


Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the medium containing 100 mg/l of tetracycline. The cell concentration of the *Agrobacterium* strains was adjusted to 10<sup>8</sup> cells/ml. The *Agrobacterium* strains were then mixed with the plant cells and the transformation efficiency was determined. The results are shown as the mean  $\pm$  SD of three independent experiments. The asterisk indicates a significant difference ( $p < 0.05$ ) between the two strains.
