FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Kill Koba and production tubing.
2. Run radioactive log.
3. Run in with 3-1/2" frac tubing with packer. Set packer at approximately 4120.
4. Frac open hole producing section from 4150 to 4650 with 15,000 gallons refined oil and 15,000 pounds sand in 2 stages with 1000 pounds moth balls between stages.
5. Plug well back on production.

Current Producing Interval: Open hole from 4150 to 4650.

Current test: 6-7 57, 22 hours pumping, 10 bbls. oil, no water, Gas 3934.
