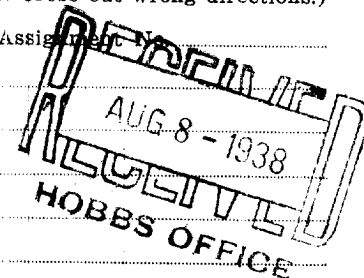

20. $\text{C}_2\text{H}_5\text{Br}$ and $\text{C}_2\text{H}_5\text{I}$ are prepared by reacting ethyl alcohol with HBr and HI respectively.
