1. Ran tubing open ended to 8904', spotted 500 gallons 15% NEA, pulled tubing.
2. Perforated 8790' - 8842', 8866' - 8900' w/2 JSPF.
3. Ran 272 jts. (8356') 2" tubing & hung @ 8367', Sweet HD-100 packer @ 8336'. Sweet Side Door Choke @ 8332'. Displaced acid to formation.
4. Reset packer @ 8855', tubing @ 8889'. Treated perforations 8866' - 8900' w/2000 gallons 15% NEA. Pulled straight thru tool & ran side door tool. Treated perforations 8790' - 8842' w/3000 gallons 15% NEA. Pulled blank off tool, tubing & packer.
5. Reran tubing w/RBP & RTTS treating packer @ 8756'.
6. Treated all perforations w/10,000 gallons 15% NEA.
7. Recovered load.
8. On OPT flowed 188 BOPD + 2 B BS thru 16/64" choke. FTP 100 psi. Gravity 40.2 deg. API.
