In the subject well we perforated 5-1/2" Csg. @ 3079-85, 3113-23, 3130-37 and acidized perforations w/7000 gals. acid. We were unable to recover any sizable amount of formation oil. Some perforations were sand-oil frac w/3500 gals. oil + 1# sand per gal. and was followed later by a 12,000 gal. sand oil treatment. We were at this date unable to recover any load oil and propose to temporarily abandon well. We propose to cap this well and hold for further evaluation for workover or recompletion.
