Detailed account of work done, nature and quantity of materials used, and results obtained.

This well was spudded at 11:00 PM February 17, 1961. It was drilled to 330' in Red Bed. Ran 10 joints 13 3/8" OD 48# H-40 SS Casing (308.36) set at 325.76. Cemented with 325 sacks neat cement. Plug was down at 2:45 PM 2-19-61. Dumped 1 1/2 yards pea gravel outside casing at 35'. Cemented outside casing with 35 sacks neat cement. Cement was allowed to set 24 hours prior to testing for shut-off. Tested casing with 1000 pounds for 30 minutes before drilling plug. Tested casing with 1100 pounds for 30 minutes after drilling plug. Results were satisfactory. Drilling resumed.


