This well was drilled to TD 9017' in Dolomite, ran 254.6 jts. of 5 1/2" OD 17# N-80; 17# J-55; 15 1/2" J-55 or 9004.29' set @ 9017' w/D.V. tool set @ 7354'. Cemented 1st stage w/100 cu ft. 50% Diamix w/1# Flocele & 6% gel per cu. ft. plus 250 sax incor neat. Cemented 2nd stage w/825 cu. ft. 50% Diamix 6% gel plus 50 sax incor neat. Plug down 8:05 PM, 6-3-61. Cement allowed to set 48 hrs. before testing for shut off. Tested casing w/1000# pressure during 30 minute interval with no drop in pressure. Top of cement 4100' cement drilled out to PBD 9014'. Completion continuing.
