DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

T. D. 4687 Lime. Plugged hole back 4687' to 4440' with 75 sacks cement. Mudded hole to top with 11# mud. Shot 7" casing with 2 qts. LNG each at 3500' 3400', 3300' and 3185'. Recovered 3175' of 7" casing. Cemented hole with 50 sacks 3100' to 2969' and with 30 sacks 1780' to 1708' thru drill pipe. Hole full of mud. Broke down drill pipe and filled hole with 11# mud to within 10' of surface. Bridged hole 10' from surface and cemented from bridge to surface with 6 sacks cement. Put in pipe marker. Cellar and pits were filled. Location abandoned.
