Injected 20 bbls. lease oil treated w/5 gallons Chemicals. Flushed w/20 BO. Swabbed dry.
Loaded hole w/oil. Spotted 250 gallons 7 1/2% MCA & washed perforations. Set packer.
Pumped 250 gallons MCA into formation & flushed w/20 BO. Swabbed dry.
Treated formation via casing w/10,000 gallons gelled lease crude containing 1#/gallon sand
& 0.1#/gallon Adomite in 3 stages w/30 ball sealers. Overflushed w/50 BO.
Ran 2" x 1 1/2" x 12' Sargent pump.

On OPT pumped 45 BOPD + 41 BOPD w/11-64" SPM. GOR 699.
