- Set permanent packer at approximately 4800' between Zones I and IIIA perfs. 3.
- Run 2" plastic coated tubing with seal assembly and dual packer spaced to set 4. at 4710'.
- 5. Run 1" plastic coated tubing with seal assembly and set dual packer.
- Load annulus with inhibited water. 6.
- Hook up plastic coat d well head and start injecting into upper zone at rate 7. of 73 B/D and lower zone at rate of 64 B/D.
