3. Run tubing open ended w/2" x 2 1/2" swage on bottom.
4. Run rods and pump.
5. Treat via casing annulus w/400 bbls. hot fresh water containing I-5 and follow w/2000 gallons 15% Dolowash.
6. Recover load.
7. Place on production.
