1. Pull rods, pump and tubing.
2. String shoot casing perforations with 1-100 grains/foot, and 1 - 300 grains/foot shot.
3. Run tubing open ended with 2 1/2" x 2" swage on bottom. Hang above casing perforations.
4. Treat with 2000 gallons 15% Dolowash acid, using ball sealers.
5. Flush to formation.
6. Run rods and pump.
7. Recover load.
8. Place back on production.
