This well had fish in hole with top at 4672'. On 8-20-74 a CIBP was set at 4650' and capped with cement up to 4615'.

Proposed plugging procedure.

1. Displace fluid in hole with 9# mud.
2. Determine free point of 5 1/2" casing, cut and pull while keeping annulus filled with mud.
3. Set 100' cement plug 330' to 430'.
4. Set 10 sx cement plug from surface to 28'.
