We propose to do the following:

1. Pull rods, pump & tubing & scrap perforations.
2. Run retrievable bridging plug to 4730' $\frac{1}{4}$
3. Treat via casing w/20,000 gallons lease crude containing 1# sand & 0.1# Adomite per gallon. Follow first 10,000 gallons w/17 balls.
4. Run tubing w/retrieving head & seating nipple.
5. Pump load & test & return to production.
