**DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED**

With 13" OD casing set @ 281' and cemented with 250 sacks of common cement at 11 p.m. November 29, 1938, the well was allowed to stand undisturbed for a period of 48 hours. The cement plug was then drilled and the hole bailed dry. The hole was undisturbed for one hour, after which time the bailer was again run. There was no water present.

Drilling was resumed. December 2, 1938.
