DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3750' - Total Depth. Lme. Finished drilling 11" hole @ 8:30 AM, 11/26/52. Ran a total of 91 Jts of 8-5/8" casing set @ 3750' w/1500 sac cement. Pumped plug to 3664' at 2 AM, 11/27/52. Max pump pressure, 1000#. Ran temperature survey, top of cement outside 8-5/8" casing at 1361', or, 44.5% fill. After WOC for 24 hours, tested casing for 1/2 hour w/1000#, - no pressure drop. drilled cement from 3664' to 3750' and tested casing with 1000# for 1 1/2 hours - no pressure drop. Started drilling formation and 7-7/8" hole @ 1:30 AM, 11/29/52 -
