DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3750' T.D. Lime - Finished drilling 11" hole @ 12 Noon, 11/25/53 - Ran a total of 90 Jts of 8-5/8" OD Casing set @ 3750' W/1500 sacks. Pumped plug to 3696' @ 7:45 AM, 11/27/53. Max pressure 1300#. Ran temperature and found top of cement outside 8-5/8" OD Casing @ 607', or, 58.6% fill. After WOC for 24 hours drilled cement from 3662' to 3750'. Tested casing before and after drilling cement with 1000# - OK. Started drilling 7-7/8" hole from 3750' @ 9:30 PM, 11/27/53.
