DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Red and tubing was pulled. Ran Gamma Ray Survey, check perforation from 6160' to 6279', Set Baker Retainer at 6251.5 with wire line. Tested retainer, same would not hold. Ran Halliburton Packer set in blank pipe at 6215', squeezed well with 40 sacks cement. Swabbed tested below packer perforations, sealed dry test. Set packer at 6120', acidized with 4,000 gal. special low tension acid. Well now producing from perforations 6160' to 6180', 6185' to 6205'. Waterfree.
