- 1) Move in pulling unit. Pull rods and tubing.
- 2) Treat Paddock open hole section 6120-6204' with 500 gallons of 15% NE acid.
- 3) Run 2-3/8" OD internally plastic coated injection tubing.
- 4) Circulated with water treated with corrosion inhibitors.
- 5) Set tension packer at approximately 6020'.
- 6) Connect to water injection system and commence injection.
