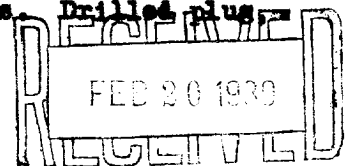

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

At 11:30 AM February 15, 1939, 48 hours had elapsed since setting 15" OD casing at 299' and cemented with 200 sax. At this time we tested in the following manner:

Built up 1000# pressure, closed valves and held for 30 minutes. Drilled plug built up 22 1000# pressure and again held for 30 minutes.

Tests were okay and drilling was resumed.
