At 12:00 Noon November 22nd, 72 hours will have elapsed since setting 5 $\frac{1}{2}$ " casing at 4543' with 300 sacks cement. At this time we plan to test shutoff in the following manner:

Build up pressure to 1000#, close valves and hold for 30 minutes. Drill plug, again build up pressure to 1000#, close valves and hold for 30 minutes. If test is OK, drilling will be resumed.
