At 3:00 A.M. November 22nd, 72 hours will have elapsed since setting 8-5/8" casing at 3108' with 500 sacks cement. At this time we plan to test shutoff in the following manner:

Build up pressure to 1000#, close valves and hold for 30 minutes. Drill plug, again build up pressure to 1000#, close valves and hold for 30 minutes. If test is OK, drilling will be resumed.
