DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On October 7, 1952 at 8:30 P.M. 36 hours had elapsed since running 254' of new 13 3/8" casing landed at 269' and cemented with 275 sacks cement circulated to surface.

Casing shut off was tested with 475 psi for 30 minutes before and 450 psi for 30 minutes after drilling plug. There was no drop in pressure on either test and drilling operations were resumed.

Well was spudded 10/5/52.
