DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On March 7, 1953, at 8:30 A.M. 36 hours had elapsed since running 3283' of new 9-5/8" casing landed at 3296 and cemented in two stages as follows:

1st Stage: Cemented with 150 sacks neat cement.

2nd Stage: Cemented with 150 sacks neat cement. (Temperature survey indicated top of cement at 1550').

Casing shut off was tested with 1000 psi for 30 minutes before and 1050 psi for 30 minutes after drilling DV tool and 1050 psi for 30 minutes after drilling shoe. Since there was no appreciable drop in pressure on any test drilling operations were resumed.
