## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On February 28, 1953 at 12:05 P.M., 30 hours had elapsed since running 263' of new 13-3/8" casing landed at 274' and cemented with 275 sacks neat cement, circulated to surface.

Casing shut-off was tested with 475 psi for 30 minutes before and after drilling shoe. Since there was no appreciable drop in pressure, drilling operations were resumed.
