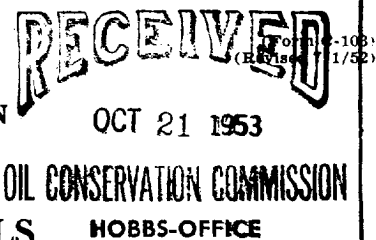

Ran 5147' of 5-1/2" liner @ 8460', Top of liner @ 3313', cemented w/600 sax 4% gel, 200 sax neat, did not circ. Squeezed top of liner @ 3313 w/75 sax neat, pressure 1800#.

Tested top of liner @ 3313 w/2000# 30 min. last 200# 30 min. Tested 5-1/2" liner w/1900# 30 min. before drilling plug, no break. Tested w/1800# 30 min. no break after drilling plug.
