The method of producing this well was changed from flowing thru 2" tubing to flowing thru 2" tubing by gas lift as of January 6, 1944. On test, this well produced 61.78 bbls. oil per day on 60/64th" choke. Gas used to gas lift this well is being furnished by our State "E" Tract 17 Lease, Well No. 1.
