In order to shut off water in the above well we propose the following: Set drillable retainer at 8400' and squeeze perforations 8430-8480' with 200 sacks slo-set cement leaving 10' cap on top of retainer. Perforate 8338-8354' with 2 shots per foot, acidize with 500 gallons 15% acid and flush with 50 barrels oil. Test well and return to production.
