DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On April 23, 1953, ran 265' of 13-3/8" casing landed at 259' and cemented with 275 sacks neat cement circulated to surface. After 30 hours tested casing with 800 psi for 30 minutes. No drop in pressure. Drilled 30' of good cement to bottom of shoe, and tested with 450 psi for 30 minutes. No drop in pressure. Drilling operations were resumed.

Well spudded 1:30 A.M., 4-23-53.
